REGULATION

During the current year, we have admitted 13 new Freemen and advanced 8 Freemen to Liverymen, with our June Court meeting still to go. These show a strong continuing interest in joining the Company and advancing. If you are interested in advancing to become a Liveryman, then please contact the Clerk who will be delighted to assist you.

Under the enthusiastic leadership of the new chairman of our Social committee, Vaughan Robinson, we have held a wide range of events in addition to our four main dinners and lunch. The attendance at these events has been very encouraging, with some of them sold out – so please do book early as it is sometimes possible to increase capacity at our events but only if we have advance notice.

At the March meeting, the Court set the quarterage rates for our year commencing 1 July 2019 as follows:

Resident in the UK

Freemen and Liverymen (aged 40 and over) 275.00 Freemen and Liverymen (aged under 40) 137.50

Resident overseas

Freemen and Liverymen (all ages) 137.50

These rates represent the lowest of all of the Modern Livery companies and The Court has worked incredibly hard to maintain these at such a low level.

The Treasurer will be sending out the quarterage invoices in early July. For those paying by direct debit, the amounts will be collected on or just after 1 August 2019.

Last year, 40% of our members signed up to have their quarterage collected by direct debit. The process for signing up with GoCardless is very simple and there were no problems with the collection of the payments. I would strongly encourage all members who have not set up a direct debit to consider doing so for next year. This helps you by ensuring that your payments are collected on time and helps the Company by reducing the time that we have to spend chasing payment.
