



History of Tax: The Jeffrey-Cook Lectures: Tuesday 3rd February 2026

The Debt Experiment: How the History of Taxation Informs the Future of Public Debt

with Dr Maria Kendrick

We do hope you will be able to join us for our next History of Tax event, either in person at Information Technologists' Hall, London, or via zoom.

Synopsis: The world is currently on an unsustainable trajectory of increasing public debt with a corresponding necessity to find tax revenue for repayment. This is leading to calls to find new taxes to generate revenue to repay the debt. However, this is not a new phenomenon.

In her lecture, Dr Maria Kendrick will explain how the history of taxation informs the future of public debt in a manner that seems both historically repetitive and experimental, considering the potential impact this might have on new forms of finance and governmental structures.

Biography: Dr Maria Kendrick is a Senior Lecturer in Law at The City Law School at City St George's, University of London, a member of the Exam Board for the MSc in Taxation at the University of Oxford, Research Fellow at the Centre of European Law, King's College London and a Member of the Institute for the Study of European Law (ISEL) at City, St. George's, University of London. Dr Kendrick is also a Liveryman of the Worshipful Company of Tax Advisers and Co-Chair of its Young Members' Group. She read Law at King's College London and was a Centre of European Law Scholar at King's obtaining her PhD in 2018 along with a lifetime Fellowship. Her research profile is in EU and international tax law, including integration and differentiated integration. She has published extensively on EU tax law and differentiated integration, including EU own resources and both indirect and direct tax proposals to repay the NextGenerationEU debt. She has submitted expert evidence to Parliamentary Committees, being cited by the House of Lords Sub-Committee on the Protocol on Ireland/Northern Ireland on taxation and subsidies.
