



# HISTORY OF TAX: Tuesday 14th October 2025

## THE ORIGIN OF THE CGT EXEMPTION FOR THE HOME

with David Collison

We do hope you will be able to join us for our next History of Tax event, either in person at Information Technologists' Hall, London, or via zoom.

**Synopsis:** The UK is unusual in having a full exemption on the gain made on the sale of the home. David will give an account of the deliberations leading to the decision to grant full exemption when CGT was introduced in 1965. David's lecture is based on research he has undertaken of the Inland Revenue policy discussion papers of the period and also the private papers of Prof Nicholas Kaldor, Special Advisor to the Chancellor at that time.

The conception of a new tax required, in David's analysis, the coming together of academic thought, political pragmatism and public acceptance. This, he considers, is well illustrated in the granting of the PPR exemption. David proposes to complete the lecture session by leading a discussion on the question: "What is the fundamental nature and purpose of the UK capital gains tax?"

**Biography:** David is the author of a dozen books on taxation, including eleven editions of *Tiley & Collison: UK Tax Guide*. As well as running a consultancy practice, David has been Vice-President of Euro-Audit and Chairman of the Education Committee of CIOT.
