

Freedom of the City of London by Redemption in a Livery Company

When you have received the Freedom of your Livery Company, you are required to obtain the Freedom of the City of London before you can proceed to the livery.

You are eligible for the Freedom of the City of London if you are above the age of eighteen years, not an undischarged bankrupt and not having been convicted of a criminal offence. Applicants need not disclose convictions that have been spent under the Rehabilitation of Offenders Act 1974.

Once completed, you should email the [Court Assistant](#) with scans of the following official documents (certified translations are required of documents that are not in the English language):

- Livery Company Freedom document.
- Full birth or adoption certificate. A full birth certificate shows the names of parents and exact place of birth; a short one does not. Applicants can order a replacement certificate [via the GOV.UK website](#).
- A woman who uses a married surname should bring her marriage/divorce certificate.
- Applicants using names other than those registered on their birth, adoption or marriage certificate should provide an official document showing changes – for example, a change of name deed, passport or driving licence.
- Applicants who have completed their apprenticeship and apply via Servitude should also provide a copy of their indentures.

The fee of £185 (from 1st April 2025), known as the ‘Freedom Fine’, is paid by BACs transfer, for which details are provided on the application form. If your name is on the Ward List (City of London electoral roll) there is no fee, but please ensure you provide the Ward address where you are registered to vote and click on “Not applicable (Ward list, registered voter at above address)” at the bottom of the online form.

Freedom Admission Ceremony

Your application will be submitted to the next Court of Aldermen for approval (unless you are a Ward List applicant or Servitude). Subject to the approval of the Court, you will receive an email from the Chamberlain's Court office inviting you to make an appointment for your Freedom admission ceremony.

Freedom ceremonies take place each working day between 10.30am and 12pm and between 2pm and 3.30pm, usually in the Chamberlain's Court Room, Guildhall. You will be asked to read aloud the Declaration of a Freeman and to sign the Declaration book, after which you will receive your copy of the Freedom (City Freedom certificate). No special dress is required, but you are expected to be of smart appearance – no jeans or trainers. Friends and family are most welcome to attend.

Please bear in mind that there is a 3-month waiting period from the Court date to the ceremony. Some Livery Companies arrange group ceremonies – please check with your Clerk, should you wish to be admitted with fellow members of your Livery Company.

Declaration of a Freeman

"I do solemnly declare that I will be good and true to our Sovereign Lord King Charles the Third; that I will be obedient to the Mayor of this City; that I will maintain the Franchises and Customs thereof, and will keep this City harmless, in that which in me is; that I will also keep the King's Peace in my own person; that I will know no Gatherings nor Conspiracies made against the King's Peace, but I will warn the Mayor thereof, or hinder it to my power; and that all these points and articles I will well and truly keep, according to the Laws and Customs of this City, to my power."

Non-British and British Commonwealth Citizens have the option to substitute "our Sovereign Lord" with "His Majesty".
